# 3. Review of Minutes of Meeting #7 - December 14, 2014 including Business Arising

## 4. Committee Reports:

### 4.1 Internal Committee:

- no specific actions to report goal is to get processes established and written down
- posting the date of the meeting should be the facilitator that does this perhaps mention that the room is accessible although best to give prior notice to facilitators to be sure that elevator is operable.
- internal committee should put together a checklist of role of recorder (running draft by steering committee)
- final Bus Riders of Saskatoon meeting minutes should be sent to Online Committee to put on Website, cc. Mandy for archiving, online committee will put PDF link on Facebook. Timeline for completion of minutes one week after meeting.
- Tracey suggested that in order to put forth an action or attend meetings on behalf of Bus Riders that there needs to be some set criteria e.g. Having attended a meeting in the last 4 months, attended the previous meeting
- longer term goal skill sharing Q what do people want? Tutorials on use of Facebook, Google docs and Google group

#### 4.2 Online Committee:

- Stephan willing to help get more content up on the website and volunteered to join the committee
- Marianne reported that they have implemented measures to make website more secure, and that Rob has assisted in making site more user friendly
- discussion of rules consensus that opinions can be expressed without them being endorsed by Bus Riders. it should be clearly marked as opinion but the more the comment the better
  - would be good to add a 'comment section' to the opinions posted
- Marianne will use Facebook to invite people to submit content for posting
- members should e-mail online committee if there are transit related items that could be posted
- Sarina will send Marianne links that have been posted on FB page
  - concern expressed that links do get taken down would be good if screen shots were taken Mandy has volunteered to do this
- suggested that the more hits and Google searches are done, the more we come up on searches individuals could make our page their home page
- Marianne suggested that we should put a link on the Facebook page whenever we put something new on the website
- Stephan noted that the more 'known' a site is, the less likely it will be flagged by security software as a possibly risky site.
- Marianne reported that the committee will be meeting shortly and will put together a draft terms of reference

City of Saskatoon – Standing Policy Committee on Transportation – January 12, 2015

<u>Presentation by Bus Riders of Saskatoon – Re: Management Response to Letter from University</u> of Saskatchewan School of Environment and Sustainability

Good morning,

City Councillors and members of city administration:

My name is Robert and I am here to speak on behalf of Bus Riders of Saskatoon. I must say, we are somewhat disappointed in the contents of the report. We are pleased that the Growing Forward Shaping Saskatoon planning initiative <u>does</u> focus on improving public transit as a key area for action in the future. We are concerned however that the response to so many of the recommendations related to public transit is only that they will be addressed by Growing Forward. We feel it is the responsibility of the Standing Committee on Transportation and on City Council as a whole to champion improved transit right now.

Two Recommendations put forward in the letter were not addressed:

- 1) <u>Lead by example</u>: We encourage all Councillors and those advising you on transit matters to ensure that you have personal experience using the transit system. We feel you need to experience the challenges faced by Bus Riders getting route and schedule information, exploring fare options, catching the bus, riding on the vehicle itself, and completing transfers. Councillors make decisions for the whole city. You need to have first hand knowledge not only of the challenges faced by the citizens in your ward, but in other parts of the City as well. We know from your comments that some of you have this experience but we aren't sure that all of you have.
- 2) <u>Conduct a market analysis to determine at what cost people will change their transportation choices</u>: If we are going to increase ridership, the Saskatoon Transportation System needs to attract new riders. It should be realized that all of those who have to take the bus are already taking the bus. The system needs to attract those who currently choose <u>not</u> to take the bus. We suggest that you undertake this marketing study but enlarge it to capture not only cost, but to explore and quantify other factors which enter in to people's transportation choices and how these barriers can be eliminated.

A third recommendation is that the City collaborate with and consider input from community organizations that are focused on improving transportation in the city: We appreciate the ongoing relationship Bus Riders of Saskatoon is building with Saskatoon Transit Management.

We would like to see the establishment of a formal Transit Advisory Committee with a wider representation to reflect a growing need for public transportation in our growing city.
